Subject: Admissibility of Covid-19 Vaccination to Employees, their dependents & In-house OPD RECHS Beneficiaries – Guidelines for COVID19 Vaccination of children between 12 to 14 years and Precaution Dose for persons 18 years or above.

With effect from 16.03.2022, India's National COVID Vaccination Program has allowed COVID-19 Vaccination of children in the age-group of 12-14 years with "Corbevax" as the only vaccination option. Additionally, Government has also done away with the condition of co-morbidity for COVID19 Precaution Dose for population over 60 years of age with effect from 16.03.2022.

Accordingly, "Corbevax" vaccine is added to the list of vaccines which are reimbursable under Rule 4.2 of Medical Attendance Rules - Treatment for immunizing and prophylactic purposes. The rate of reimbursement of "Corbevax" vaccine wef 16.03.2022 will be limited to Rs. 990 per dose (inclusive of all taxes and vaccine administration charges) capped to maximum of two doses subject to production of vaccination certificate and bill/ receipt.

Further, the precaution dose of all COVID vaccines has been made permissible to all persons aged 18 years or above with effect from 10.04.2022. The charges of COVAXIN and COVISHIELD has been fixed as INR 386.25 wef 10.04.2022 which is inclusive of all taxes and vaccine administration charges and accordingly reimbursement is to be made subject to production of vaccination certificate and bill/ receipt.

The vaccination is being administered free of cost in Government Hospital/ arrangement. Thus, employees, their dependents and RECHS beneficiaries should use these facilities to the extent possible. Wherever such facilities are not available and vaccine is required to be taken on payment basis, the reimbursement of COVID-19 vaccination may be made to the eligible beneficiaries based on rates as given above. The process of reimbursement of COVID-19 vaccine including precaution dose will be same as was done earlier.
